## Professional Development

On-site training for school district staff on topics such as:

- Trauma Informed Care
- Autism Spectrum Disorders
- Positive Behavioral Supports
- Differentiated Instruction
- Curriculum Modifications

Cost: Please see fee structure sheet. (Please note that any professional development will require a minimum of 2 hours per session.)

## Professional Consultation

On-site consultation by professional staff that can include:

- Functional Behavioral Assessment
- Development of Positive Behavioral Intervention Plan
- Strategies to address challenging behaviors
- Strategies for modifying curriculum

An average Professional Consultation service will be 4 hours which includes time for observation and reports.

## On-Site Supports

After professional consultation, staff from Catholic Charities provides on-site support, working directly with school staff and students to implement the intervention plan and any additional strategies. Support services are transitioned from Catholic Charities staff to school district staff.

## On-Site Supports – Segregated Setting

Catholic Charities staff works directly with a student in a segregated setting within the home school. Catholic Charities staff is responsible for developing and implementing a program of support. Once the program is developed and demonstrates success, the student is re-integrated into the classroom setting and supports are transferred back to school district staff.

## Segregated Setting

Student attends a segregated setting off campus and CC staff is responsible for developing and implementing a program of support. This option is for students who present significant safety risks in the home school setting.

## Fee Structure

School Districts: \$1,000.00 per month for 9 months. If a district requires more than \$1,000.00 of service in any month, the additional time will be invoiced monthly. Services can be selected based on options above. Please see fee schedule for additional information.

## Travel

A travel fee of \$40.00 will be assessed for each site visit per day. If multiple sites are visited in any given day, those school districts will share the travel costs.
